

### YOUR MONEY MATTERS

This monthly newsletter is aimed at saving our readers valuable tax dollars. First, all NYC residents should file a tax return EVEN if they are below filing guidelines, since NYC will give all residents a tax credit of \$115 (single) and \$230 (married). The amount was raised this year from \$63 and \$125, respectively. Every resident is entitled to this benefit. If someone did not take advantage of this benefit, all is not lost. One can recoup this benefit for the last 3 years by filing the correct City forms.

Additionally, The Basic STAR is available to all home, condo, and co/op owners regardless of age or income. Seniors (age 65 by Dec. 31) with a household income of \$67,850 or less may be entitled to the Enhanced Star. Most NYC taxpayers will save \$200 per year with Basic and \$375 with the Enhanced STAR. Outside NYC, (i.e., Nassau, Westchester) the savings are dramatically higher.

My name is Brent Dorrough and I am a Master Sergeant with 14 years of service in the Marine Corps. I was born and raised in Georgia and am currently stationed in Virginia, but I'm hardly ever there... Go figure. My team mates and I are here in Iraq serving on what is known as a MiTT team, and we'll be here for an entire year (ending this December). MiTT stands for Military Transition Team. MiTTs are at the forefront of the effort to get US forces out of Iraq, basically we have to train these guys how to run their own military and then get out of their way. Sounds easy right? Hardly! There are only 11 of us on this team, 10 Marines and one Navy Corpsman ( medical guy ).

You can not imagine just how grateful we are to receive packages in the mail. Our BP ( battle position or base) is extremely isolated out on the Syrian border and we have absolutely no way to get the essentials that we need on a daily basis. We do have access to a few things when we travel to the nearest FOB ( forward operating base) in Al Qaim, but even there the supplies we can purchase are very limited. So, I guess you could say that wonderful Americans like yourself are our WalMart.... Seriously, we are very appreciative of the fact that you have not only spent some of your precious time and money to go out and buy these things for us, but also to package and mail them to, us. Those are all very nice things that you have done, for people you have never met and trust me, it always puts a smile on our faces and makes us feel appreciated. Especially with all of the negativity in the news that we hear about, it is good to know that we still have some supporters out there. God Bless y'all
